# **Chapter I. General Provisions**

**Article 1.** This regulation establishes the manner and criteria for granting scholarships to students of the George Emil Palade University of Medicine, Pharmacy, Science, and Technology of Târgu Mureş.

**Article 2.** In accordance with the Education Act no. 1/2011, Ministry of Education Order no. 3392/2017, Ministry of Education Order no. 4104/2017, Ministry of Education Order no. 4366/2017, and Ministry of Education Order no. 5076/2017 scholarships are granted to students in state higher education – full-time education – according to the study results obtained and the financial status of the student's family.

Thus, scholarships granted to UMFST G.E. Palade Târgu Mureş students are: scholarships for the stimulation of academic achievement (scholarships of excellence, didactical achievement scholarships, scientific achievement scholarships, merit scholarships), special scholarships (merit scholarships for sports activities), and social aid scholarships (social scholarships and occasional social scholarships).

**Article 3.** The funds for granting scholarships from the state budget are allocated to higher education institutions by the Ministry of Education, in ratio to the total number of students enrolled in full-time university education, without a study fee, undergraduate and Master's degree programs in the institution respectively, based on the institutional contract for the scholarship fund. These funds can be augmented by amounts from the own funds of the university. These funds are then allocated to faculties, study programmes, years of study, and teaching languages, in ration to the total number of students. The allocation of the scholarship fund to faculties is approved by the Administrative Board.

**Article 4.** The following are not criteria for granting any type of scholarship from state budget funds: student status on a budget or tuition fee basis, age, gender, religion, race, nationality, citizenship, sexual orientation, political affiliation of the candidate or his/ her family, the membership in organisations legally constituted or in accordance with the European legislation in force, the number of years spent in other educational institutions, the studies conducted abroad, as well as access to scholarships from other sources.

- **Article 5.** The amount of scholarships, irrespective of their type, shall be approved by decision of the Senate, upon proposal of the Administrative Board, following consultation with students' representatives, including representative student organizations within the university.
- **Article 6.** (1) Scholarships, regardless of category, are awarded throughout the academic year (12 months), with the exception of the social ones that are reviewed each semester.
- (2) Students enrolled in the last year of study of bachelor or master's study programmes who benefit from any type of scholarship in the last semester of study of the cycle shall be awarded the same type of scholarship/ scholarships until the end of the academic year, including the period of final examinations (graduation, dissertation, etc.).
- (3) Students transferred from other state higher education institutions, other faculties or other study programmes, enrolled in full-time education, may benefit from scholarships starting with the academic year following the transfer, provided the criteria for granting scholarships are met.
- (4) Students who have requested the interruption of studies shall benefit from the scholarship starting from the academic year following the return from the interruption, provided the criteria for awarding scholarships are met.

### Article 7.

- (1) Social scholarships shall be reviewed at the beginning of each semester and shall be granted on request, depending on the socio-economic situation of the student's family and the general criteria established by the Order of the Ministry of Education no. 3392/2017 and the specific criteria developed in line with its own methodology.
- (2) When establishing the amount of the social scholarships, the starting point is the minimum amount, set annually by CNFIS.
- (3) The amount of social scholarships shall be determined, by decision of the University Senate, at the proposal of the Administrative Board, within the limits of available funds and identified needs at the level of the student community, observing the provisions of paragraph (2).
- **Article 8.** The amount of the achievement scholarships is higher than the merit scholarship. The amount of merit scholarship is higher than the amount of the social scholarships.

Article 9. Within the university is established, with the approval of the Administrative Board, University Scholarship Board is established, composed of 5 members of which 2 students, the Chief Secretary of the faculty, and it is coordinated by a Vice-rector. Within each faculty, a Faculty Scholarship Board is established, consisting of 5 members, of which 2 students, coordinated by a Vice-dean. Also, with the approval of the Administrative Board the University Medical Board is established, consisting of 5 members, the Athletic Merit Board is established, of 3 members and the Board of Appeals at the university level, with a similar composition, coordinated by another vice-rector.

# Chapter II. Specific awarding criteria

**Article 10.** The categories of scholarships granted by UMFST G.E. Palade of Târgu Mureş and the specific criteria for their granting are specified by the Order of the Ministry of Education no. 3392/2017, as subsequently amended and supplemented.

Achievement scholarships are granted to students who have a very good professional activity and have achieved meritorious results in scientific research. The scholarships awarded for the achievement stimulation provided in art. 4 par. (1) of Ministry Order 3392/2017 may be awarded to students who fall into at least one of the following categories:

- have achieved outstanding learning outcomes, i.e. they have the highest average of the same year of study in a study programme;
  - have achieved scientific performances, innovation and patents;
  - other situations established by universities through their own regulations.

The achievement grants awarded by UMFST G.E. Palade of Târgu Mureş are:

- 1.) Scholarships of excellence:
- awarded to students who finished with an average of 10.00 two consecutive years.
- 2.) Scientific performance scholarships will be awarded through Junior Research Academy.
- 3.) Didactic achievement scholarships:

- are awarded to the best students in the year/ series, provided the weighted average is at least 9.75, calculated after the summer session of examinations:

### 4.) Merit scholarships:

- a) are allocated according to study programmes, study years and teaching lines, directly proportional to the total number of students;
- b) may be granted to students in the first year, according to the average obtained at the admission examination, by study programmes, in proportion to the number of students in each study programme, at the proposal of the scholarship board of each faculty and the approval of the scholarship board of the university;
- c) will be granted to students from years II-VI who at the end of the summer session of examination have the weighted average over 8.00; if two students with the same weighted average apply for a scholarship, the following selection criteria are taken into account:
  - selection criteria I arithmetic average;
  - the selection criteria II if the arithmetic averages are equal the marks obtained in the subjects with the most credits from the last academic year are taken into account. If there are several disciplines with the same maximum number of credits, the arithmetic average is made of the marks from the disciplines with the same number of credits.
  - the selection criteria III if the marks or the average of the examinations for the disciplines with the most credits are equal, the process from the of selection criteria II is continued in descending order of the number of credits.
- d) scholarships not allocated to students at the end of the summer session of examination may be granted to students who have passed all the examinations in the subjects of the curriculum of the academic year (compulsory and optional subjects), with a weighted average of over 9.00 and no more than one failed examination at the end of the summer session; if two students with the same weighted average apply for a scholarship, the arithmetic mean is taken into account; if the arithmetic averages are equal, the following selection criteria are taken into account:
  - selection criteria I arithmetic average;
- the selection criteria II if the arithmetic averages are equal the marks obtained in the subjects with the most credits from the last academic year are taken into account. If there are several disciplines with the same maximum number of credits, the arithmetic average is made of the marks from the disciplines with the same number of credits.
- the selection criteria III if the marks or the average of the examinations for the disciplines with the most credits are equal, the process from the of selection criteria II is continued in descending order of the number of credits.
- e) the unallocated scholarships for students who have passed all the examinations and students with a weighted average over 9.00 at the end of the summer session, may be awarded to students who have passed all the exams at the subjects of the curriculum of that academic year with a weighted average over 9.50 with two failed examinations at the end of the session summer; if two students with the same weighted average apply for a scholarship, the following selection criteria are taken into account:
  - selection criteria I arithmetic average;

- the selection criteria II - if the arithmetic averages are equal - the marks obtained in the subjects with the most credits from the last academic year are taken into account. If there are several disciplines with the same maximum number of credits, the arithmetic average is made of the marks from the disciplines with the same number of credits.

- the selection criteria III if the marks or the average of the examinations for the disciplines with the most credits are equal, the process from the of selection criteria II is continued in descending order of the number of credits.
- f) after the scholarships are granted, according to the criteria in the Regulation and the abovementioned provisions, if there are undistributed scholarships, these are redistributed according to the same principles, to students in the years/ study lines provided there are eligible students, within each faculty, study programme, the ratio being related to the number of eligible ones.

### Article 11. Social assistance scholarships::

- - are granted upon request (see Annex 01 and Annex 03), to students with poor financial/personal situation;
  - permanent social aid scholarships or occasional social assistance grants.

**Article 12.** *Permanent social assistance* grants are awarded to students during their studies up to the age of 35, in one of the following categories:

- (1) students orphaned by one or both parents, respectively for whom placement has been ordered as a protection measure and who do not earn income above the limit for granting the social assistance scholarship. Students in this category have priority when awarding social assistance scholarships.
- (2) students **suffering from** tuberculosis who are under medical records, during tuberculostatic treatment, insulin-requiring diabetes, malignancies, serious malabsorption syndromes, chronic renal disease on dialysis, moderate or severe persistent bronchial asthma, grand mal epilepsy, congenital heart diseases, chronic hepatitis with advanced fibrosis (stage F3 or F4), glaucoma, severe myopia, severe forms of autoimmune immunological diseases, rare diseases, autism spectrum disorders, severe hematological diseases, conditions which require continuous treatment or frequent hospitalizations, bilateral deafness, cystic fibrosis, HIV-infected or AIDS patients, locomotor disorder and classified as disabled;
- (3) students whose families, in the last three months preceding the beginning of the semester/ academic year, have not reached an average net monthly income per family member higher than the net minimum basic salary;
- (4) students from state higher education institutions, to whom the provisions of art. 10 paragraph r) of Law no. 42/1990, republished, based on the certificate issued by the Board for the enforcement of Law no. 42/1990, certifying their quality or one of the parents of "Fighters for the Victory of the Romanian Revolution of December 1989" or "Hero-martyr" with one of the terms: injured, detained, injured and detained, remarked by special facts, accompanied by the certificate signed by the President of Romania;
- (5) from the scholarship fund allocated to universities, at least 30% of the total is allocated to the category of social aids;

(6) if the fund for granting scholarships is not used in full, it shall be redistributed for the granting of merit scholarships.

### Article 13.

- (1) Determination of the monthly average net income of the student's family shall be made until the age of 26, taking into account the incomes of the parents and of the children in their care, and of the family members under the care of the student: wife, children, if applicable, taking into account:
- salary incomes and other incomes, according to the provisions of Law no. 227/2015 regarding the Fiscal Code, as subsequently amended and supplemented;
- retirement pensions, including those for war invalids, orphans, widows/ widowers, fixed amounts for the care of first grade invalid pensioners, regardless of whether they are from the state budget or voluntary pension funds and regardless of their type, in accordance with Law no. 263/2010 on the unitary pubic pension system, as subsequently amended and supplemented;
- income from agricultural activities according to the provisions of Law no. 227/2015 regarding the Fiscal Code, as subsequently amended and supplemented;
- state child allowances, in accordance with Law no. 61/1993 on the state child allowance, republished, as subsequently amended and supplemented;
- placement allowances in accordance with Law no. 272/2004 on the protection and promotion of children's rights, republished, as subsequently amended and supplemented;
- income from medical leave for pregnancy or postpartum confinement or compensation for temporary incapacity for work, in compliance with the legal provisions in force;
- grants, allowances, and other forms of special purpose support provided from the state budget, state social insurance budget, special fund budgets, local budgets and other public funds, including those from non-reimbursable external funds, as well as those of the same nature received from other persons, except for allowances for temporary incapacity for work, including allowances for: maternity risk, maternity, childbirth and the care of the sick child;
- income generated from the sale of movable assets in the form of waste through collection centres for dismantling, which are the subject of national programs financed from the state budget or from other public funds:
- cash and in-kind rights received by active soldiers, short-time soldiers, pupils and students of national defence education, public order and national security, and civilians, as well as those of graduates and soldiers concentrated or mobilised;
- any income from economic activities by authorised natural persons, individual enterprises and family enterprises, in the sense of Government Emergency Ordinance no. 44/2008 on conducting economic activities by authorised natural persons, individual enterprises and family enterprises, approved with amendments and supplementations by Law no. 182/2016. In the case of estimated income on the performance of economic activities by authorised individuals is divided by 12 months
  - any income from liberal professions and the exploitation of intellectual property rights;
  - dividends in the last 12 calendar months. The monthly average is calculated by reporting them to 12.

(2) For students aged between 26 and 35, their net average monthly income will be calculated taking into account only the personal income of the student and his/ her dependents, such as children, wife, etc., in accordance with the legal provisions in force.

(3) Proof of the family nucleus, in special situations, to be established on the basis of an act issued by The Local Community Public Service for the Record of the Persons, to whom the student belongs"

### Article 14. Occasional social aid:

- (1) Students may occasionally benefit, **on request**, on the basis of supporting documents, from *occasional social assistance aids*, regardless of whether the student benefits from another scholarship category:
- the occasional social assistance aid for clothing and footwear, which can be awarded to students with one or both deceased parents, or for whom a placement has been ordered as means of protection, for socio-economically disadvantaged students whose family has not had, in the 3 months preceding the application for this type of aid, an average monthly net income per family member of the net national minimum income. This category of aid may be awarded to the same student twice during an academic year;
- the occasional maternity social allowance granted to a female student or a student whose wife does not earn any income or earns **under** net national minimum income and consists of a birth grant and a grant and a scholarship for the procurement of the new-born baby's clothing, which is granted only once during the academic year for each child born;
- the occasional social assistance aid in case of death may be granted for the death of a member of the student's family. **The family member** is the parent (mother, father), husband, wife, child. In the case of the death of the unmarried student, married to a non-earning spouse, the aid is granted to first-degree relatives/ legal successors only once during the academic year.
- (2) The occasional social assistance aid may be awarded twice during one academic year (once a semester) upon **the student's request** (with the obligation to submit in due time the dossier with the necessary documents to the deans' offices), within the limits of the funds allocated for social aids or extrabudgetary funds of the University, and in amounts at least equal to the minimum scholarship.
- Article 15. In order to grant social assistance scholarships, students will submit (see Annex 3) the following supporting documents on the basis of which the classification in one of the types of scholarships offered is carried out:
- documents proving the income of the student, and his/ her family. If neither parent receives an income, the Social Survey establishing the average income per family member and the means of subsistence is mandatory;
- for situations where there are reasonable suspicions, the board for the evaluation of the application for the social aid may ask the student to submit the social investigation report, in compliance with the legal provisions, which will reveal the exact situation of his/ her family. Social investigation is mandatory if the student's parents work or live abroad;
  - copies of the parent/ parents' death certificate(s), if applicable;

- a certificate from a specialist physician other than the general practitioner, and a copy of the complete medical file presenting the evolution and clinical picture of the medical problem the student suffers from and falling within the provisions of **Art. 11** par. (2).

If there are suspicios about the medical files submitted by the candidate, the Commission for awarding scholarships of the faculty can may request the candidate for a specialized medical re-examination in the university center.

**Article 16**. The special scholarships that can be awarded are sports merit scholarships:

- (1) Students enrolled in undergraduate education, with remarkable results in performance sports, can obtain on a competitive basis, *sports merit scholarships*. The amount of the sports performance scholarships is approved by the University Scholarship Board, with the approval of the Senate;
- (2) Students applying for sports merit scholarships shall complete an individual application form to the *faculty Scholarship board* at the beginning of the academic year. The Board will set the closing date for the submission of applications;
- (3) Students who apply for a sports merit scholarship will include documents that justify their personal performance. Sports performance must be achieved over the last five years from the date of submission of the application;
- (4) The student applying for the sports merit scholarship must accumulate 60 credits (ECTS) in the previous academic year (except for first year students);
- (5) The criteria on the basis of which the hierarchy of candidates for Sports merit Scholarships is established are based on the grid in Annex 02 to this regulation. The criteria are as follows:
  - qualifying in Olympic games;
  - ranking in places I-VIII in official world competitions;
  - ranking the 1<sup>st</sup> to the 6<sup>th</sup> places in official European competitions;
  - obtaining a title of national champion in official competitions of seniors;
  - obtaining at least two junior national championship titles;
- obtaining at least two II-III places in national championships, under the aegis of specialised sports federations;
  - national team member (representative team member) by age category;
  - member of a national sports excellence centre, subordinated to the Ministry of Education;
  - member of a divisional team of seniors from the first national echelon.

The documents proving the sports performances that fall under the mentioned criteria are submitted

**Article 17.** Students can benefit from any type of scholarship for a single undergraduate program, for a single master's programme, except for scholarships for graduate and postgraduate studies.

**Article 18**. (1) A student cannot receive two types of scholarships simultaneously from the same category, but has the right to choose the one with higher value or to be granted for a longer period of time.

(2) By way of exception to paragraph (1), students benefiting from social aid may receive any other type of scholarship regulated by this Regulation.

(3) Students who fall under the provisions of paragraph (2) and who have the right to receive both the performance scholarship and the merit scholarship must opt for one of them, with the possibility of choosing the higher one.

### Article 19.

The documents required to obtain the social assistance aids in each of the above categories are specified in Annex 03.

## **Chapter III. Final provisions**

### Article 20.

- (1) Information on how to access and grant scholarships shall be published on the website and at the headquarters of the university at the beginning of the academic year.
- (2) Notices for the submission of applications and supporting documents in order to obtain scholarships are published on the website and on the university/ faculty board at least 15 working days before the deadline for their submission.
- (3) The scholarship boards established within the university and each faculty shall analyse the submitted files as well as the statistical statements drawn up at the deans' offices and shall approve the nominal lists of the students receiving scholarships.
- (4) Upon publication of the results, students may file complaints within 2 working days at the University Registry. Complaints will be settled by the Complaints Board within a maximum of 7 calendar days. The results as well as the final lists with the students receiving scholarships shall be published on the university website, after which these data are also sent to the Social Service.

**Article 21.** If there are suspicions of falsification of the documents submitted for obtaining social aid, the university shall notify the competent investigation bodies and sanction the student, depending on the seriousness of the act.

The Senate of the George Emil Palade University of Medicine, Pharmacy, Science, and Technology of Târgu Mureş approved this regulation on July 5, 2023 and it comes into force on July 6, 2023.
